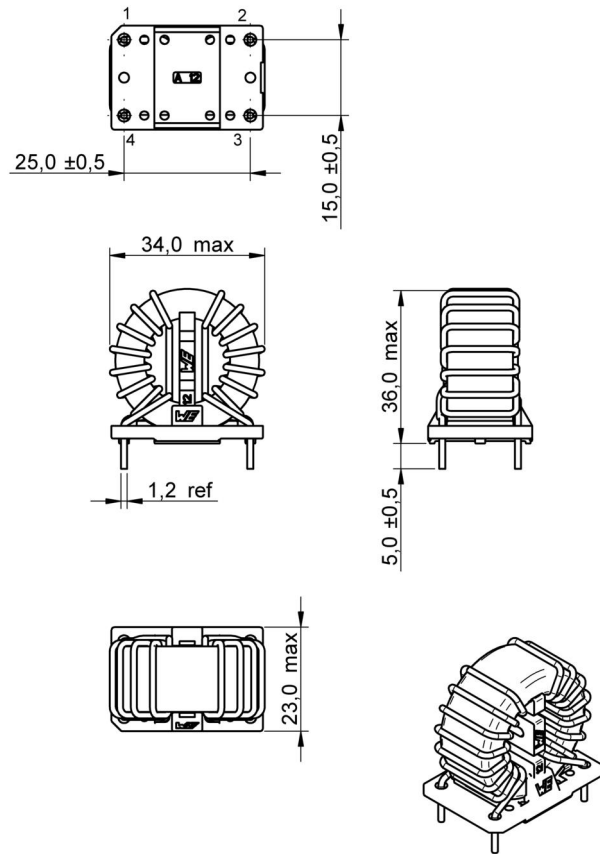
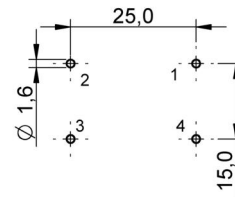

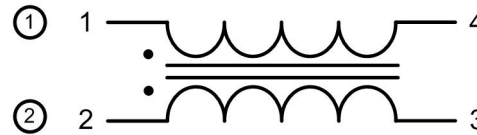

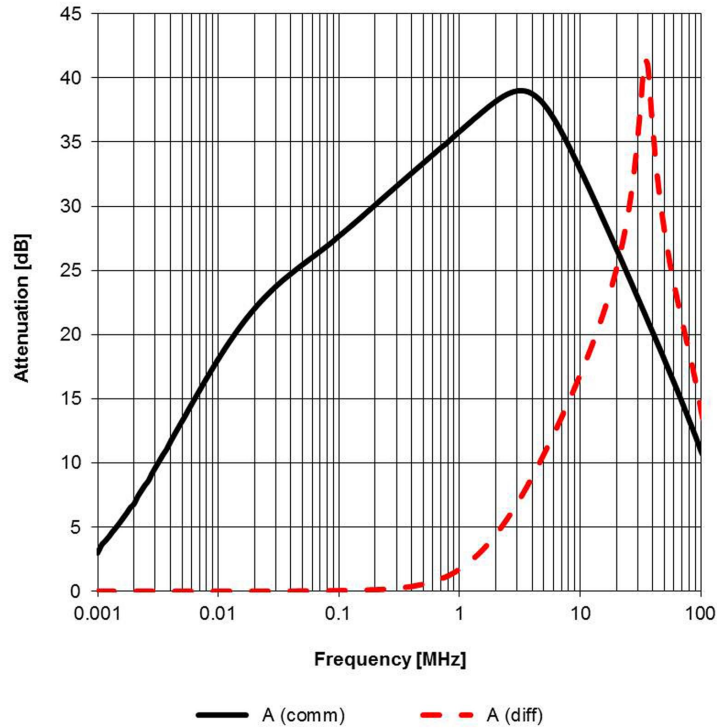



Product specific:


